WHAT DOES JACK RICE INSURANCE DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: Social Security number and Birthdate Address and Medical Information Credit Reports and Motor Vehicle Reports When you are no longer our customer, we continue to share your information as described in this notice.	
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Jack Rice Insurance chooses to share; and whether you can limit this sharing.

What we do			
How does Jack Rice Insurance protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. Nonaffiliates that perform services for us are contractually bound to keep this information confidential. Employees are informed accordingly.		
How does Jack Rice Insurance collect my personal information?	We collect your personal information, for example, when you file an application or file a claim provide account information or provide contact information transact business with our office We also collect your personal information from others, such as insurance support organizations, as permitted by law.		
Why can't I limit all sharing?	Federal law gives you the right to limit only sharing for affiliates' everyday business purposes—information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. We need to share information in our everyday business.		

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.
	 First Benefit Administrators, Inc. Modern Business Associates, Inc. and its subsidiaries
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
	Examples include insurance companies, claims personnel, software providers, auditors, and insurance support organizations.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
	 Our joint marketing partners can include insurance companies, software providers and insurance support organizations.

Other important information

Notice of information practices for Arizona, California, Connecticut, Georgia, Illinois, Maine, Massachusetts, Minnesota, Montana, Nevada, New Jersey, North Carolina, Ohio, Oregon, Vermont, and Virginia Residents:

We may collect personal information about you from persons other than you such as credit reporting agencies and insurance support organizations. We may also disclose personal information to regulatory or governmental authorities and also nonaffliates (such as to process transactions) but only to extent permitted or required by law. You have the right to request a copy and/or amend the personal information we may have recorded. We will respond to your written request within 30 business days as long as the information is easily retrievable and within our possession. There may be a reasonable fee to cover the costs incurred.
